CAPE HENLOPEN SCHOOL DISTRICT NOTICE OF SPECIAL ELECTION

TO AUTHORIZE THE LEVY OF ADDITIONAL TAXES AND THE ISSUANCE OF BONDS

Notice is hereby given that a Special Election will be held on March 26, 2024, in the Cape Henlopen School District ("CHSD" or the "District") in accordance with the provisions of Chapters 19, 20, and 21 of Title 14 of the Delaware Code, in order to permit the voters of the District to vote either for or against each of the following two items:

Section 1:

To support ongoing District operations, the Cape Henlopen School District is seeking authority to levy and collect an additional \$0.335 per \$100 of assessed value in local school taxes for current operating expenses as set forth below, effective July 1, 2024, and every year thereafter on all assessed taxable real estate in the District to fund operating expenses totaling \$5,025,000.

For a property in the District assessed at a rate of \$27,707 (Cape Henlopen School District average assessment), the increased current expense cost to the homeowner would be \$93.82.

The purpose of this proposed tax increase is to:

- Fund increased operational costs and additional staff, necessitated by the needs of our expanding student population.
- Ensure adequate resources to manage the rising expenses in utilities, personnel, maintenance costs, transportation, instructional materials and supplies, technology, and special education services.

Section 2:

The Cape Henlopen School District is seeking authority to issue bonds for Major Capital Projects in the amount of \$79,096,895 from the levy of 5.2 cents per \$100 of assessed valuation effective July 1, 2025, with an additional increase of 16.2 cents per \$100 of assessed valuation effective July 1, 2026, to be used for the following projects:

\$21,440,991 **Local Cost** Planning, equipping and construction for the planned relocation of the school district office to a new 30,000 square foot facility in Lewes, DE, to enhance operational efficiency and community accessibility through modernized facilities and centralized operations. Construction of Natatorium \$36,122,290 **Local Cost**

Planning, construction, and equipping of a 38,200 square foot school district swimming facility (Natatorium) that is intended to boost athletic and recreational opportunities, featuring state-of-the-art amenities and ample space to meet the expanding needs of students and the community. This project aims to enhance community engagement and promote long-term health and wellness through a modern, accessible aquatic center on the above purchased land located in Lewes, Delaware.

Construction of Bus Maintenance Facility

Local Cost \$5,960,614 Planning, construction, and equipping of a 4,000 square foot bus maintenance facility to improve the efficiency and reliability of transportation services, offering advanced and spacious areas for vehicle upkeep and repairs. This initiative is focused on ensuring safe and dependable transportation for students, while also fostering effective fleet management and long-term operational sustainability to be located on the above purchased land located in Lewes, Delaware.

These projects will be funded 100% locally for a total of \$79,096,895 (Cape Henlopen School District's local share)

Notes regarding the above table: Estimated "Annual Tax Increase" amounts are rounded and are stated in Cents/\$100 of Assessed Value. The "Annual Tax Rate" is based on the District's current debt service rate (\$0.0691 per \$100 of assessed value) and several other factors including market interest rates. Retirement of existing debt will offset annual tax increases in future years. The calculations in the above table were prepared without regard to any future referenda that may be pursued by the District.

Voters may only vote one time in this special election even if the voter has more than one child attending school in the Cape Henlopen School District.

QUALIFICATIONS TO VOTE

- · Must be a citizen of the United States and Delaware
- Must be a resident of the Cape Henlopen School District
- Must be 18 years of age or older
- · You do NOT have to be a registered voter for purposes of a general election

ABSENTEE BALLOT

You may vote by absentee ballot if you cannot vote at a polling place on the day of election for one of the following reasons:

- You are temporarily or permanently disabled;
- You are serving in the public service of the U.S. or the State of Delaware;
- You are the spouse or a dependent living with or accompanying a person serving the U.S. or the State of Delaware;
- The nature of your job or occupation does not permit you to go to the polls;
- You are sick;
- The tenets or teachings of your religion prevent you from voting on the days or times set for the election;
- You are incarcerated but otherwise eligible to vote;
- You are away on vacation;
- You are the caregiver to a parent, spouse or that person's child who is living at home and requires constant care due to illness or injury;
- You are temporarily living outside of the U.S.;
- You cannot go to the polls because of illness or injury received while serving in the Armed Forces; or
- You serve in the Armed Forces, Red Cross, U.S.O., or the Merchant Marine; or
- You are authorized pursuant to the federal Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) [42 U.S.C § 1973ff et seq.], or any other federal law, to vote by absentee ballot.

To vote by absentee ballot:

- If you want an absentee ballot mailed to you, send a completed application so that it arrives at the Department of Elections, Sussex County Office

- In order to be counted, voted absentee ballots must be received at the Department of Elections, Sussex County Office, 119 N. Race St., Georgetown, DE 19947 no later than 8 p.m. on Tuesday, March 26, 2024.
- Vote in person by absentee ballot at the Department of Elections, Sussex County Office, Mon-Fri from 8:30 a.m. to 4 p.m. until Friday, March 22, 2024, or from 8:30 a.m. to 12 Noon on Monday, March 25, 2024.
- NOTE: If you are a voter with a "permanent absentee status," this status does cover school elections. You will not automatically be mailed an absentee ballot. You must request one. Please follow instructions above to request an absentee ballot.

PROOF OF IDENTIFICATION AND ADDRESS

Persons appearing to vote must present satisfactory proof of identity and address to the Election Officers at the Polling Place before being permitted
to vote. Persons who do not present satisfactory proof of identity and address may – upon majority vote of the Inspector and the two Judges – be
permitted to vote.
